




Return on Average Assets*




Net Interest Margin*




Eighth District Payroll Employment by Industry—2003


YEAR-OVER-YEAR PERCENT CHANGE IN YEAR-TO-DATE LEVELS

YEAR-OVER-YEAR PERCENT CHANGE




Real GDP Growth


Civilian Unemployment Rate


