LOUIS, MO — The Federal Reserve Bank of St. Louis, acting pursuant to delegated authority for the Board of Governors of the Federal Reserve System, today approved the application by Cross County Bancshares, Inc., Wynne, Arkansas (Applicant), to acquire additional voting shares of Central Bank, Little Rock, Arkansas, pursuant to Section 3(a)(3) of the Bank Holding Company Act of 1956, as amended.
