SUBJECT: Federal Reserve offers \$5 billion in 28-day term deposits through its Term Deposit Facility.

HIGHLIGHTS: On Monday, July 25, 2011, the Federal Reserve will offer \$5 billion in 28-day term deposits through its Term Deposit Facility. As noted in the Federal Reserve Board's September 8, 2010 release, this offering is part of ongoing small-value operations designed to provide eligible institutions with an opportunity to become familiar with term deposit operations.
